Tonkinese Visit with Pawdancer Cattery

1) 11-week old, Blue Mink male, Kitten

Young kitten so it could use more muscle tone and development. Body is medium in length. Blunt muzzle, kitten has proper profile with slight rise from tip of nose to stop, gentle contour from stop to forehead and a slight convex curve to the forehead. Eye color could improve with age, a little more blue for now. Ears set as much on top as on the side with oval tips.

2) 7 years old, Platinum Point female, Grand Champion

Open almond shaped eye with brilliant blue color. Well-muscled, medium length body. Coat medium short, close-lying with soft silky feel. Rounded wedge shape head, ears a little high, profile as desired.

3) 11-week old, Champagne Mink female, Kitten

Muzzle too pointed, not as long as it is wide. Body is a little shorter than the desired medium length torso. Good ear set, as much on top as on the side of the head. Eye color a little blue, could improve with age.

4) 1 year old, Natural Solid female, Champion

Well-developed muscular feel to the body. Head is a little Burmese looking and is a little shorter, rounder and more extreme, less moderate. Sable brown body color. Open almond shaped eye.

5) 1 year old, Champagne Mink female, Champion

Body is a little soft, less muscular feeling. Body is a little narrow as is head. Ears are set too high rather than as much on the side as on the top. Bump to nose rather than a gentle rise from the tip of the nose to the stop.

6) 8 years old, Natural Solid spay, Grand Champion, Grand Premier

Medium length, well-muscled body. Close-lying silky coat. Sable brown color. Open almond eyes on a modified slightly rounded wedge shaped head. Blunt muzzle as long as it is wide. Ears as much on top and on high. Profile has a slight stop at eye level

7) 4 months old, Natural Mink male, Kitten

Great muscular feel to his medium length body. Slightly rounded wedge shaped heads. Ears a little higher than they should be on his head. Eyes are almond shaped but not quite open in appearance as they are a little small. Chin is a little weak and could be stronger. Dark brown natural color, aqua eye color.
